

COMMITMENT TO THE ERASMUS CHARTER PRINCIPLES

Declaration

I, undersigned, declare that if my institution is awarded with an Erasmus Charter for Higher Education, my institution will undertake to:

- Respect in full the principles of non-discrimination, transparency and inclusion set out in the Programme.
- Ensure equal and equitable access and opportunities to current and prospective participants from all backgrounds, paying particular attention to the inclusion of those with fewer opportunities.
- Ensure full automatic recognition of all credits (based on the European Credit Transfer and Accumulation System – ECTS) gained for learning outcomes satisfactorily achieved during a period of study/training abroad, including during blended mobility.

- Ensure that outgoing mobile participants are well prepared for their activities abroad, including blended mobility, by undertaking activities to achieve the necessary level of linguistic proficiency and develop their intercultural competences.
- Ensure that student and staff mobility is based on a learning agreement for students and a mobility agreement for staff validated in advance between the sending and receiving institutions or enterprises and the mobile participants.
- Provide active support to incoming mobile participants throughout the process of finding accommodation.
- Provide assistance related to obtaining visas, when required, for incoming and outgoing mobile participants.
- Provide assistance related to obtaining insurance, when required, for incoming and outgoing mobile participants.
- Ensure that students are aware of their rights and obligations as defined in the Erasmus Student Charter.

During mobility

- Ensure equal academic treatment and the quality of services for incoming students.
- Promote measures that ensure the safety of outgoing and incoming mobile participants.
- Integrate incoming mobile participants into the wider student community and in the Institution's everyday life. Encourage them to act as ambassadors of the programme and share their mobility experience.
- Provide appropriate mentoring and support arrangements for mobile participants, including for those pursuing blended mobility.
- Provide appropriate language support to incoming mobile participants.

After mobility

- Provide incoming mobile students and their sending institutions with transcripts of records containing a full, accurate and timely record of their achievements at the end of their mobility period.
- Ensure that all ECTS credits gained for learning outcomes satisfactorily achieved during a period of study/training abroad, including during blended mobility are fully and automatically recognised as agreed in the learning agreement and confirmed by the transcript of records/traineeship certificate. They shall be transferred without delay into the student's records, shall be counted towards the student's degree without any additional work or assessment of the student and shall be traceable in the student's transcript of records and the Diploma Supplement.
- Ensure the inclusion of satisfactorily completed study and/or traineeship mobility activities in the final record of student achievements (the Diploma Supplement).
- Encourage and support mobile participants upon return to act as ambassadors of the

programme, promote the benefits of mobility and actively engage in building alumni communities.

- Ensure that staff is given recognition for their teaching and training activities undertaken during the mobility period, based on a mobility agreement and in line with the institutional strategy.

WHEN PARTICIPATING IN EUROPEAN AND INTERNATIONAL COOPERATION PROJECTS

- Ensure that cooperation activities contribute towards the fulfilment of the institutional strategy.
- Promote the opportunities offered by the cooperation projects and provide relevant support to staff and students interested in participating in these activities throughout the application and implementation phase.
- Ensure that cooperation activities lead to sustainable outcomes and that their impact benefits all partners.
- Encourage peer-learning activities and exploit the results of the projects in a way that will maximise their impact on individuals, other participating institutions and the wider academic community.

El desarrollo del programa Erasmus + en Musikene tendrá lugar principalmente a través de acciones de KA1 y KA2. En torno a esto, dentro de las movilidades a desarrollar en KA1 y siendo Musikene un centro de educación superior musical nos planteamos la continuación de movilidades de estudiantes y personal en sus diferentes modalidades con países del programa. También prevemos la apertura a proyectos de movilidad con países asociados al programa, con el fin de ampliar las redes de cooperación de nuestra institución y del Programa Erasmus + en las enseñanzas superiores de música.

Como eje principal de desarrollo del programa en KA2 participaremos activamente en el diseño y desarrollo diferentes Asociaciones Estratégicas que facilitarán la cooperación y la transferencia de prácticas educativas entre instituciones.

Además de continuar desarrollando estas implementaciones en las que ya venimos trabajando, también estamos abiertos a valorar la ampliación de nuestra participación en el programa Erasmus + en otro tipo de asociaciones para la excelencia.

De esta manera, el programa Erasmus + continuará siendo una herramienta que facilita la internacionalización y la modernización de nuestro centro y con él de las enseñanzas superiores de música. Así, nos gustaría lograr que no solo los participantes directos del programa se beneficiaran de sus principios y acciones, sino que a través de la "internacionalización en casa" podamos ampliar el impacto del concepto tradicional de internacionalización.

El programa Erasmus + forma parte de la estrategia de internacionalización e innovación nuestro centro. Esto se refleja en diversos ámbitos entre los que cabe destacar: los proyectos de asociación (cooperación o innovación) que permiten desarrollar la conciencia social y europea, así como contribuir en otros temas como el son el patrimonio musical-cultural o el compromiso con el entorno social y la inclusión, líneas de trabajo prioritarias en la estrategia de innovación del centro. Además, la diversa procedencia de nuestro personal docente, con un elevado número de profesorado internacional, nos permite profundizar aún más en esta premisa.

La garantía de calidad constituye otro de los ejes estratégicos de Musikene para los siguientes cursos y el programa Erasmus + se implementará en todo momento bajo sus principios, atendiendo a la transparencia, documentación y el seguimiento de las distintas fases de los proyectos a realizar, así como el reconocimiento completo de las actividades realizadas dentro del programa.

Además de la contribución que como institución realiza a las prioridades de Área Europea de Educación, Musikene forma parte de la AEC, Asociación Europea de Conservatorios, lo que realza mucho más aún la implicación de los principios del programa Erasmus +, ya que la misión de la AEC se centra en el desarrollo de temas como la responsabilidad social, diversidad e inclusión en el ámbito internacional de las enseñanzas superiores de música.

Con todo esto, la participación en proyectos y asociaciones dentro del programa Erasmus + nos permite mostrar la visión, experiencia y realidad de la educación superior musical.

Los objetivos específicos que se plantean en Musikene son:

- Promover la apertura de nuevas redes de contactos que nos permitan la realización de movilidades Erasmus + con países del programa y asociados.

- Aumentar el número de profesorado que participa en acciones del programa Erasmus +, bien sea a través de la movilidad como de su participación en el diseño o implementación de proyectos.
- Crear dinámicas que permitan que la movilidad de personal se establezca como una de las vías para la formación continua y el desarrollo profesional.
- Participar en proyectos de asociación KA2 relacionados de los intereses y prioridades principales de Musikene.
- Introducir los principios del *Erasmus Without Paper* en las gestiones del programa
- Asegurar procedimientos de calidad en la gestión del Programa Erasmus +
- Desarrollar estrategias de integración para los estudiantes extranjeros atendiendo a la diversidad de los mismos.

The carrying out of the Erasmus+ programme in Musikene will take place mainly through KA1 and KA2 actions. Around this, within the mobilities to be carried out in KA1 and with Musikene being a higher musical education centre, we propose the continuation of student and staff mobilities in their different modalities with countries belonging to the programme. We also foresee the opening up of mobility projects with countries associated with the programme, with the aim of extending the cooperation networks of our institution and of the Erasmus+ programme in the higher teaching of music.

As the main axis of development of the programme in KA2, we will actively participate in the design and development of different Strategic Associations which will facilitate cooperation and the transfer of educational practices across institutions.

In addition to continuing developing these implementations on which we have already been working, we are also open to evaluating the extension of our participation in the Erasmus+ programme and in other types of associations for excellence.

In this way, the Erasmus+ programme will continue to be a tool facilitating internationalisation and modernisation of our centre and, with it, of the higher teaching of music. Thus, we would like to achieve that not only the direct participants of the programme benefit from its principles and actions, but that through "internationalisation at home" we can extend the impact of the traditional concept of internationalisation.

The Erasmus+ programme is part of the internationalisation and innovation strategy of our centre. This is reflected in diverse fields among which we can highlight: association projects (cooperation or innovation) allowing the development of social and European awareness, as well as contributions in other areas such as musical and cultural heritage and commitment to the social environment and inclusion, priority lines of work in the centre's innovation strategy. In addition, the diverse backgrounds of our teaching staff, with a high number of international teachers, allows us to delve even deeper into this premise.

The guarantee of quality is another of the strategic axes of Musikene for the forthcoming courses and the Erasmus+ programme will be implemented at all times under its principles, paying attention to transparency, documentation and the monitoring of the different phases of the projects to be carried out, as well as the complete recognition of the activities carried out within the programme.

In addition to contributing as an institution to the priorities of the European Area of Education, Musikene is part of the AEC, the Association Européenne des Conservatoires, which underlines all the more the involvement of the principles of the Erasmus+ programme, given that the mission of the AEC is focussed on the development of issues such as social responsibility, diversity and inclusion in the international field of higher teaching of music.

With all this, participation in projects and associations within the Erasmus+ programme allows us to show the vision, experience and reality of higher musical education.

The specific objectives proposed in Musikene are:

- To promote the opening up of new contact networks allowing us to carry out Erasmus+ mobilities with countries inside the programme and partners.
- To inform Musikene staff of the options offered by the Erasmus+ programme and to continue promoting the participation in, and creation of, new projects.
- To increase the number of students actively participating in Erasmus+ mobilities and in its different mobilities, whether as direct beneficiary of mobility grants or participating in activities related to internationalisation at home.
- To increase the number of teaching staff who participate in actions of the Erasmus+ programme, whether through mobility or through their participation in the design and implementation of projects.
- To create dynamics allowing the mobility of staff to be established as one of the means of continuous training and professional development.
- To participate in KA2 related association projects regarding the main interests and priorities of Musikene.
- To introduce the principles of *Erasmus Without Paper* in the programme management.
- To ensure quality procedures in the management of the Erasmus+ Programme.
- To develop integration strategies for foreign students, paying attention to their diversity.
- To guide the educational community in the possibilities offered by the European Union in training and professional development.
- To open participation as listeners to the activities of the programme, especially the Masterclasses, to ex-students, professionals from the music world and the teaching staff of professional level centres and music schools in the Basque Country.

Durante el periodo 2021-2027 las acciones en las que Musikene participará se centrarán principalmente en:

- Movilidad de alumnado. Se continuará con la movilidad para estudios y estaremos abiertos a las posibilidades que nos ofrece la movilidad para prácticas.
- Movilidad personal para docencia. Dentro de esta acción continuaremos fomentando el intercambio de personal donde se comparten buenas prácticas educativas o de diseño curricular, de manera que los beneficios del programa no redunden únicamente en los individuos, sino que la comunidad educativa y en definitiva la estructura organizativa de Musikene se vea mejorada.
- Movilidad de personal para formación. Se profundizará en la difusión de esta acción para lograr que se integre de manera orgánica como mecanismo de formación de los diferentes departamentos y se perciba como una vía de desarrollo profesional del personal.
- Asociaciones estratégicas. Musikene muestra apertura en todo momento a participar en nuevos proyectos como socios o como coordinadores que nos permitan ampliar nuestra visión sobre las enseñanzas musicales. Así mismo desde la institución se contribuirá a que cristalicen los proyectos de AAEE en lo que ya se está participante.

La participación en estas acciones contribuirá al logro de los objetivos de nuestra estrategia institucional permitiendo tanto directa como indirectamente el desarrollo de la internacionalización y la innovación de nuestra institución y con ella de las personas que la forman. Por lo que, siendo la formación de futuros profesionales de la música nuestra misión principal, se podrá visualizar la expansión de estos principios también a través de las conexiones entre nuestra comunidad educativa y el mundo profesional.

También podemos reseñar que una mayor visibilidad del programa Erasmus + en nuestro centro nos permite implementar nuevas redes de contactos y por lo tanto enriquecer las acciones a realizar.

During the period 2021-2027, the actions that Musikene will participate in will be focussed mainly on:

- Student mobility. There will be a continuance of mobility for students and we will be open to the possibilities offered to us by mobility for work experience.
- Teaching staff mobility. Within this action, we will continue to promote staff exchanges where educational or curriculum design good practices are shared, so that the benefits of the programme do not fall only on individuals, but on the educational community and, in particular, the organisational structure of Musikene can undergo improvements.
- Teaching staff mobility for training. There will be a greater emphasis on the dissemination of this action to achieve its organic integration as a training mechanism for the different departments and for it to be perceived as a means of professional development of the staff.
- Strategic associations. Musikene displays an openness at all times to participating in new projects as partners or as coordinators where this allows us to widen our vision of musical teaching. Also, we will make an institutional contribution to the crystallisation of performing arts projects in which we are participating.

Participation in these actions will contribute to the achievement of the objectives of our institutional strategy, thus allowing both direct and indirect development of the internationalisation and innovation of our institution, and with it, of the people who comprise it. Therefore, our main mission being the training of future professional musicians, the expansion of these visions will also be visible through the connections between our educational community and the professional world.

We can also highlight that a greater visibility of the Erasmus+ programme at our centre allows us to implement new contact networks and therefore enrich the actions to be carried out.
